## Criteria for Laureate Selection Greater Richmond Business Hall of Fame May 20, 2010

Since 1988, Junior Achievement of Central Virginia has annually recognized the most esteemed leaders of the area at The Greater Richmond Business Hall of Fame.

To be considered as a Business Hall of Fame Laureate, an individual's record of business achievement must demonstrate: **a) business excellence, b) courageous thinking and actions, c) vision and innovation, d) inspiring leadership, and e) community mindedness. In addition, nominees must serve as a role model for those who follow.** Stated more simply, Business Hall of Fame Laureates are individuals whose work has moved American society in a better, stronger direction.

Laureates will be selected from two categories: Historical Laureates (*deceased*) and Active/Retired Laureates (*individuals still engaged in the day-to-day activities of their businesses or individuals who have retired from active business involvement*).

- ▲ Chairman, CEO, President, Founder, Owner, Principal or a partner of a Richmond area business
- ▲ Recognized for his or her significant business achievements
- ▲ Known for innovations pertaining to his or her industry
- ▲ Displays characteristics of sustained business excellence and integrity
- ▲ Demonstrates inspiring business and community leadership
- ▲ Is an exemplary business and civic role model
- ▲ Has a long record of professional and civic achievements that are a direct result of their use of the free enterprise system to improve the quality of the lives of those in their company and community
